- 1.2. Definition of Slow Learners:** For the purpose of this policy, slow learners are defined as students who experience difficulty in grasping concepts at the same pace as their peers. - 2.3. Advanced Education to Fast Learners:** To provide fast learners with advanced educational opportunities that challenges their abilities and nurtures their potential. Creating an environment where academic acceleration is encouraged and facilitated.
- 2.4. Fostering Excellence:** To cultivate an ethos of excellence and achievement that motivates fast learners to strive for the highest standards. To ensure that fast learners have access to advanced educational opportunities that match their abilities and interests.
- 2.5. Promotion of Diverse Learning Styles:** It strives to create an inclusive environment where diverse learning styles are valued, acknowledging that there are various pathways to success.
- 2.6. Cultivation of Inclusivity and Collaboration:** The policy aims to foster a culture of inclusivity, where slow learners feel supported and accepted, while also promoting collaboration among faculty, students, and support services to benefit these students. When necessary, external organizations or specialists may be engaged to meet individual learning needs.

## **3. Responsibilities**

#### 4. Interventions and Support Mechanisms
