Agenda 1: Confirmation of minutes of meeting of IQAC held on 02.02.2020, 12.02.2020 and 01.10.2020.

Agenda 2: Action taken report on the decision taken in the meeting of IQAC held on 02.02.2020, 12.02.2020 and 01.10.2020.

Decision: The report has been accepted.

Agenda 3: Discussion on the letters of Dr. Vipin Bahadur Singh and Dr. Shashi Kant Dwivedi, Physics Department, Udai Pratap College, Varanasi.

Decision: The matter was discussed in the IQAC meeting and it was decided that the issue of seniority of faculty members of the college did not come in the purview of IQAC. It entirely comes in to the purview of college and affiliating university administration and is governed by act and statute of the same.

Agenda 4: Discussion on the CAS promotion of the Teachers.

Decision: The issue of promotion of faculty members under career advancement scheme (CAS) was discussed in the meeting. It was informed that the process of CAS promotion is in progress. Agenda 7: Discussion on evolution of a process for providing quality education in online mode during post Covid situation and training of faculty members for framing syllabus consisting of programme and course outcome (CO/PO) of each programme /course.

Decision: Due to outbreak of COVID 19 pandemic and subsequent nationwide lockdown imposed by Govt. of India, the general teaching and learning process were affected substantially. In this regard, the IQAC team came up with various solutions for managing and imparting quality education in online mode. Following the general SOP for COVID situation the alternate measures were taken to accomplish teaching and learning process without compromising in quality education. This includes providing econtent to the students and time to time counseling to improve their mental health. Also it was decided to include CO/PO in each programme/courses and faculty members are to be trained for inclusion of CO/PO.

Agenda 8: Improving and creating e-learning.

Decision: Due to onset of the COVID pandemic in early 2020 a sudden move to online teaching were mandatorily implemented. Thus, it was imperative to streamline the modus operandi of online classes. For that the faculty members were encouraged to develop e-content and also promote students to use other digital platforms like SWAYAM, UG/PG MOOCs, e-PG Pathshala, e-content on UPC portal etc.
